It sets and follows guidelines for documentation, care, handling, display, and storage of the artworks in its care and contributes to the professional communities of photograph and time-based media conservators globally.

GENERAL STATEMENT OF RESPONSIBILITIES & DUTIES:

As an Assistant Conservator of Contemporary Art, you will play a crucial interdisciplinary role in the preservation and care of The Met's collection of modern and contemporary photographs as well as time-based media artworks. You will work closely with photograph and time-based media conservators in the department on acquisitions, exhibitions, loans, and preventive conservation efforts, as well as engage in research that is relevant to the Museum's collection and contributes to the field more broadly. You will also support the department's and the institution's commitment to education and outreach.

PRIMARY RESPONSIBILITIES & DUTIES:

- Conduct examinations of works being considered for acquisition, loan, or exhibition
- Carry out and assist with conservation documentation and treatments, as appropriate, on photographs and time-based media artworks
- Represent the conservation perspective during all stages of the exhibition planning process
- Advocate for and advise on the preventive conservation of the permanent collection
- Communicate with artists, their representatives, and other stakeholders about conservation of their artwork
- Research new and unconventional materials and techniques used in contemporary artworks
- Complete art historical, technical, and scientific investigation and share scholarly research through presentation and publication
- Represent the Department of Photograph Conservation within the Museum at educational and public events and at national and international conferences
- Support professional development of Fellows, interns, and students
- Other duties as assigned

REQUIREMENTS & QUALIFICATIONS:

- Master's level degree in the conservation of photographs, time-based media, or contemporary
 art; or commensurate experience. Regardless of specialization, you must have knowledge of
 and/or a strong interest in conservation of contemporary art, specifically photographs, time-based
 media, and their intersection.
- Minimum of six months of experience in a museum conservation lab or private conservation practice
- Strong knowledge of conservation methodologies, ethics, and techniques with demonstrated experience in conservation documentation and treatments
- Demonstrated research skills and the dedication to staying current with developments in the field
- Excellent attention to detail, problem-solving skills, and manual dexterity
- Effective communication skills, both written and verbal
- Ability to work independently, in a team-oriented environment, and in collaboration with other departments across the institution

- Demonstrated ability to adapt and produce high-level results on multiple projects with shifting priorities and deadlines
- Professional competence with computer programs, such as Word, Excel, Outlook, Adobe
 Creative Cloud, and collection management systems, such as TMS, as well as an ability to learn
 and implement new software
- Knowledge of a language other than English a plus, but not required
- A continuous drive to gain new skills and knowledge
