Therefore all candidates must declare that they are eligible to be a Trustee and Director of IIC, and are able to comply with regulations as detailed <a href="here">here</a>.

You do not necessarily need to be an IIC Fellow to be on IIC's Council, each position identifies on the scope of work, whether being a Fellow of IIC is a requirement for the role. The role, Director of Communications, on IIC Council is open to IIC members who are eligible to vote.
